RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

IN CONSIDERATION of being permitted to enter upon, be present at, or use the RIDING TRAILS/TRACK property (herein after referred to as the "premises") for any and all purposes and activities including, without limitation, the operation, engagement, racing (competitive or otherwise), or maintenance of any motorized mode of transportation, including without limitation, ATV's and motorcycles, any and all other activity incidental thereto, including without limitation the passive, casual or active observance of any of the aforementioned purposes and activities (hereinafter collectively referred to as the "Activities"), the undersigned, on behalf of the undersigned, the undersigned's personal representatives, heirs, next of kin, and any and all other persons using the premises for the Activities as a guest of the undersigned (hereinafter collectively referred to as the "Undersigned").
